

## The International Affairs Budget Working for Colorado

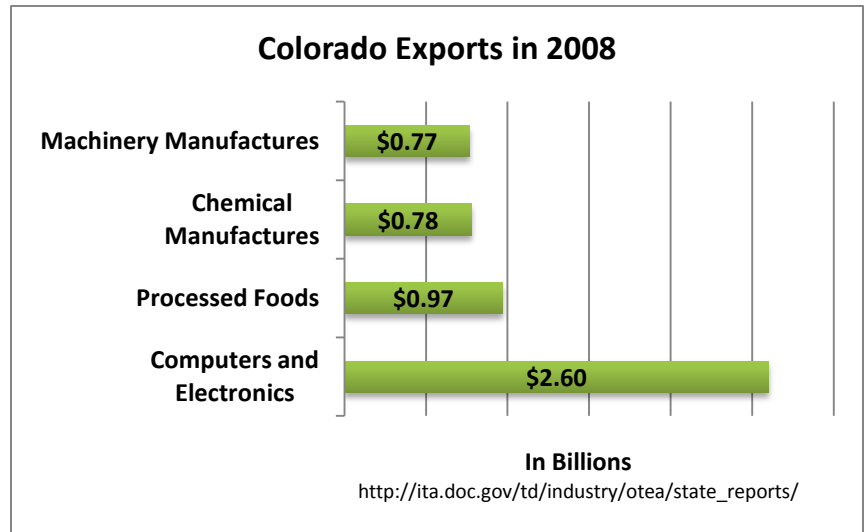
### Employment

- Trade supported 553,115 jobs in Colorado in 2006, or 18.5% of total jobs, up from 11% in 1992.<sup>1</sup> Over one-sixth (18.6%) of all manufacturing workers in Colorado depended on exports for their jobs.<sup>2</sup>
- In 2007, 81,200 people in Colorado were employed by U.S. affiliates of companies that are at least 50% foreign-owned.<sup>3</sup>



### Trade

- Colorado exported \$7.7 billion in merchandise to 197 foreign markets in 2008. Colorado's largest market in 2008 was Canada (\$2.2 billion), followed by Mexico (\$961 million), China (\$508 million), the Netherlands (\$404 million) and Japan (\$336 million).<sup>4</sup>
- In 2007, 4,459 companies exported goods from Colorado. Of these, 88% were small- and medium-sized enterprises with fewer than 500 employees.<sup>5</sup>
- Agricultural exports are important to Colorado's economy, totaling \$1.4 billion and supporting about 16,216 jobs in 2008.<sup>6</sup>
- Since 2005, the U.S. Export-Import Bank has financed over \$632 million in exports from 64 companies in 23 communities in Colorado.<sup>7</sup>



### Education

- In 2007-2008, 4,287 Colorado students studied abroad, a 12.7% increase over the previous academic year.<sup>8</sup>
- During 2008-2009, 6,857 international students were enrolled in Colorado colleges and universities and contributed \$187 million to the Colorado economy.<sup>9</sup>

### International Assistance Programs



- Since 1961, 6,341 Peace Corps volunteers from Colorado have served in dozens of countries overseas.<sup>10</sup>
- Support from U.S. government grants and contracts to private voluntary organizations engaged in foreign assistance and development in Colorado totaled \$ 7,630,023 in 2007.<sup>11</sup>
