

## The International Affairs Budget Working for Idaho

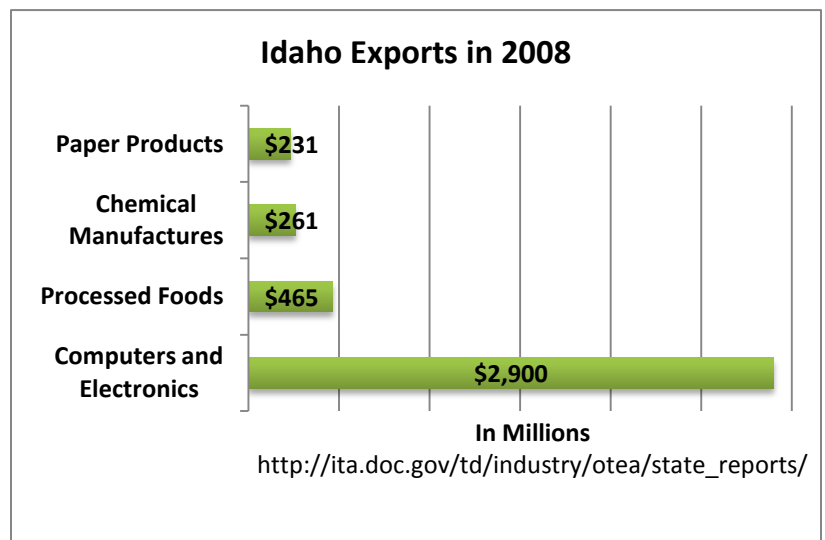
### Employment

- Trade supported 836,679 jobs in Idaho in 2006, or 18% of total jobs, up from 11.1% in 1992.<sup>1</sup> Almost one-fifth (18.6%) of all manufacturing workers in Idaho depended on exports for their jobs.<sup>2</sup>
- In 2007, 13,700 people in Idaho were employed by U.S. affiliates of companies that are at least 50% foreign-owned.<sup>3</sup>



### Trade

- Idaho exported \$5 billion in merchandise to 187 foreign markets in 2008 (a 72% increase over 2004). Idaho's largest market in 2008 was Singapore (\$1.3 billion), followed by Canada (\$952 million), China (\$394 million), Taiwan (\$347 million) and Japan (\$261 million).<sup>4</sup>
- In 2007, 1,162 companies exported goods from Idaho. Of these, 87% were small- and medium-sized enterprises with fewer than 500 employees.<sup>5</sup>
- Agricultural exports are important to Idaho's economy, totaling \$1.7 billion and supporting about 19,691 jobs in 2008.<sup>6</sup>
- Since 2005, the U.S. Export-Import Bank has financed \$62.49 million in exports from 32 companies in 17 communities in Idaho.<sup>7</sup>



### Education

- In 2007-2008, 507 Idaho students studied abroad, a 6.1% increase over the previous academic year.<sup>8</sup>
- During 2008-2009, 2,147 international students were enrolled in Idaho colleges and universities and contributed \$42.6 million to the Idaho economy.<sup>9</sup>

### International Assistance Programs



- Since 1961, 1,156 Peace Corps volunteers from Idaho have served in dozens of countries overseas.<sup>10</sup>
- Support from U.S. government grants and contracts to private voluntary organizations engaged in foreign assistance and development in Idaho totaled \$1,337,008 in 2007.<sup>11</sup>
