

## The International Affairs Budget Working for Michigan

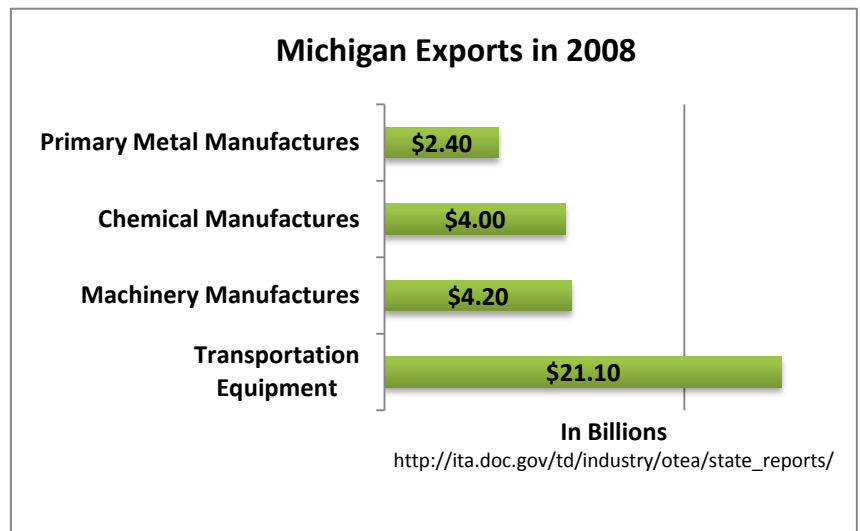
### Employment

- Trade supported 1 million jobs in Michigan in 2006, or 18.5% of total jobs, up from 10.3% in 1992.<sup>1</sup> Nearly one-quarter (24.5%) of all manufacturing workers in Michigan depended on exports for their jobs.<sup>2</sup>
- In 2007, 150,400 people in Michigan were employed by U.S. affiliates of companies that are at least 50% foreign-owned.<sup>3</sup>



### Trade

- Michigan exported \$45.1 billion in merchandise to 205 foreign markets in 2008. Michigan's largest market in 2008 was Canada (\$24.1 billion), followed by Mexico (\$6.4 billion), Germany (\$1.6 billion), Japan (\$1.4 billion), and China (\$1.3 billion).<sup>4</sup>
- In 2007, 11,205 companies exported goods from Michigan. Of these, 90% were small- and medium-sized enterprises with fewer than 500 employees.<sup>5</sup>
- Agricultural exports are important to Michigan's economy, totaling \$1.7 billion and supporting about 19,691 jobs in 2008.<sup>6</sup>
- Since 2005, the U.S. Export-Import Bank has financed over \$743 million in exports from 126 companies in 75 communities in Michigan.<sup>7</sup>



### Education

- In 2007-2008, 9,580 Michigan students studied abroad, a 3.6% increase over the previous academic year.<sup>8</sup>
- During 2008-2009, 23,617 international students were enrolled in Michigan colleges and universities and contributed \$592.4 million to the Michigan economy.<sup>9</sup>

### International Assistance Programs



- Since 1961, 6,260 Peace Corps volunteers from Michigan have served in dozens of countries overseas.<sup>10</sup>
- Support from U.S. government grants and contracts to private voluntary organizations engaged in foreign assistance and development in Michigan totaled over \$1.5 million in 2007.<sup>11</sup>
