

## The International Affairs Budget Working for New York

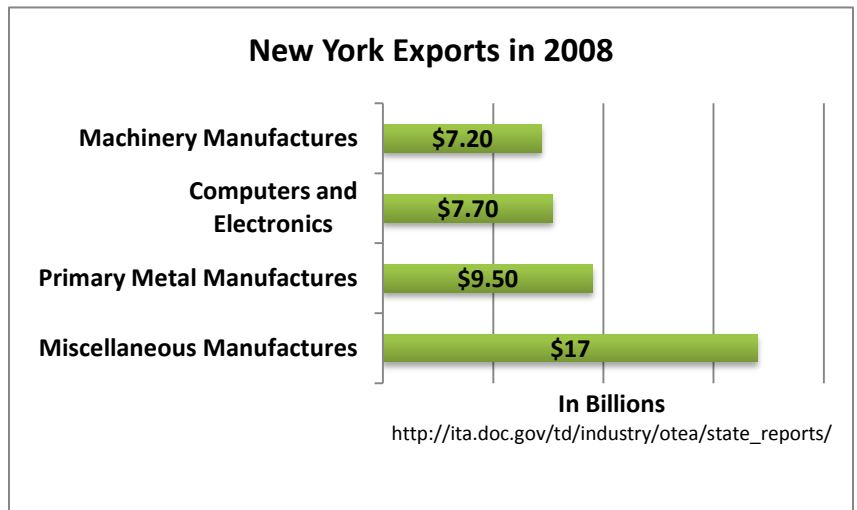
### Employment

- Trade supported 2 million jobs in New York in 2006, or 19.9% of total jobs, up from 10.4% in 1992.<sup>1</sup> Almost one-fifth (19.1%) of all manufacturing workers in New York depended on exports for their jobs.<sup>2</sup>
- In 2007, 433,600 people in New York were employed by U.S. affiliates of companies that are at least 50% foreign-owned.<sup>3</sup>



### Trade

- New York exported \$81.4 billion in merchandise to 197 foreign markets in 2008. New York's largest market in 2008 was Canada (\$16.3 billion), followed by Switzerland (\$7.9 billion), Israel (\$5.7 billion), the United Kingdom (\$5.5 billion), and Hong Kong (\$3.7 billion).<sup>4</sup>
- In 2007, 27,329 companies exported goods from New York. Of these, 94% were small- and medium-sized enterprises with fewer than 500 employees.<sup>5</sup>
- Agricultural exports are important to New York's economy, totaling \$1.2 billion and supporting about 13,899 jobs in 2008.<sup>6</sup>
- Since 2005, the U.S. Export-Import Bank has financed \$4.49 billion in exports from 249 companies in 89 communities in New York.<sup>7</sup>



### Education

- In 2007-2008, 21,277 New York students studied abroad, a 10.9% increase over the previous academic year.<sup>8</sup>
- During 2008-2009, 74,934 international students were enrolled in New York colleges and universities and contributed \$2.23 billion to the New York economy.<sup>9</sup>

### International Assistance Programs



- Since 1961, 12,017 Peace Corps volunteers from New York have served in dozens of countries overseas.<sup>10</sup>
- Support from U.S. government grants and contracts to private voluntary organizations engaged in foreign assistance and development in New York totaled over \$512 in 2007.<sup>11</sup>
