EXPORT-IMPORT BANK

FY08 Request: \$ 1 million net
FY07 CR estimate: \$ 55 million net
Change from FY07 to FY08: \$ -54 million (98% decrease)

Request for FY2008 includes funds only for the Inspector General. ExIm Bank request includes receipts collected from lending activities, a new process of accounting for the Export-Import Bank budget. The Administration estimates \$18.7 billion in lending for FY2008 compared with \$17.5 billion estimated for FY2007.

Change from FY07 to FY08: \$ 15 million (24% increase)

DEVELOPMENT ASSISTANCE (DA)

Change from FY07 to FY08: \$ -470 million (31% decrease)

There are substantial shifts of DA resources to ESF in the FY2008. Sudan and Afghanistan account for about half of the reduction compared with FY2006. Further details are needed to assess the complete impact of the request.

Part of the reduction is accounted for by shift of \$50 million for Sudan to ESF. Net reduction is \$14 million (-4.5%). Sudan receives \$114 million of the IDFA request.

The Administration says that it will accommodate the reduced request through "institutional reforms to streamline USAID and improve the efficiency and effectiveness of supporting the delivery of foreign aid." Part of the FY08 GWOT emergency is to fund USAID operating costs in Iraq.

- o *Part of the FY08 increase is the result of moving FY07 Development Assistance and Andean Counternarcotics Initiative (ACI) funds to ESF. Alternative Development transfers from the ACI total \$182 million.*
- o *Africa -- \$ 374 million, an increase of \$191 million from FY06. Most funds are concentrated in Democratic Republic of Congo, Liberia, and Sudan.*
- o *Middle East -- \$2.02 billion, \$660 million less than in FY06. Substantial FY07 supplemental (\$ 2.37 billion) and FY08 GWOT emergency (\$772 million), however, are also requested for Iraq and Lebanon.*
- o *South Asia -- \$1.43 billion, \$598 million higher than FY06. Substantial FY07 supplemental (\$653 million) and FY08 GWOT emergency (\$339 million) are also requested for Afghanistan.*

- *Latin America -- \$364 million, \$226 million higher than FY06. Of this increase, \$182 million results from the transfer of Alternative Development funds from the ACI account, leaving a net increase of \$44 million (+32%).*

Aid levels for all FSA countries decline, compared with FY06, except for Tajikistan and Turkmenistan. Russia assistance totals \$50 million, compared with \$80 million in FY06.

Most of the reduction in the ACI account is the result of shifting Alternative Development funds for Colombia, Peru, Bolivia, and Ecuador to the ESF account.

- o *Overseas assistance for FY08 totals \$498 million, \$64 million less than in the FY06 base appropriation. Of this, Africa is \$298 million, \$68 million less than in the FY06 base.*
- o *Refugee admissions for FY08 is \$213 million, \$54 million higher than in the FY06 base.*
- o *FY07 supplementals (\$71.5 million) are requested for Burundi, Democratic Republic of Congo, Palestinians, and Iraq, and a \$35 million is requested as an FY08 GWOT Emergency for Iraq.*

- o *No funds are requested for the Global Fund to Fight HIV/AIDS, Tuberculosis, and Malaria. The total amount for the Global Fund -- \$300 million -- is proposed as part of the Department of Health and Human Services budget.*

The FY08 request includes a substantial amount for cancellation of debt owed by the Democratic Republic of Congo under the Heavily Indebted Poor Country (HIPC) initiative.

FMF for Israel increases to \$2.4 billion in the FY08 request. A request of \$220 million for Lebanon as an FY07 supplemental is also made.
