The global realities of the 21st century require America to utilize the full range of non-military tools as a fundamental pillar of our national security. Investments in our international affairs programs bolster our national security by allowing us to work with foreign partners to track down terrorists and weapons, to improve the economic and political lives of others, and to help stabilize fragile states.

National security and foreign policy experts across the political spectrum support an increase in the International Affairs Budget as an essential component of our national security. The 2006 National Security Strategy, the Pentagon's Quadrennial Defense Review, the 9/11 Commission and the Baker-Hamilton Iraq Study Group all conclude that diplomacy and development reduce long-term threats to our national security and call for increased investments in the full range of diplomatic, development and humanitarian tools to deliver long-term U.S. foreign policy success.
